- Technical Data Sheet – TDS,
- Safety Data Sheet – SDS, in accordance with EU Regulations 1907/2006 and 878/2020
- Documentation required for registration in the Chemical Inventory of the Republic of Srpska: consent from the manufacturer or supplier, product label (drum), full composition up to 100% (if this information is not available in the Safety Data Sheet). If the manufacturer does not wish to disclose the full composition, the information about the chemical composition can be sent directly to the Ministry of Health and Social Welfare of the Republic of Srpska,

- Technical Report (engine tests and other tests) - Technical report (may be in electronic form as well as other documents at the request of),
- Country of origin – Statement,
- REACH – status,
- Quality report,
- Results of laboratory analysis
